



1	Product line	Stands for xMate Control Cab
2	Product algebraic identification	1 represents the first generation
3	Industrial computer identification	The default value is 0. No option is available
4	Power level marking	1: Suitable for CR7, power 1kW; 2: Suitable for CR12 and CR18, power 2kW; 3: ADAPTS to CR20 and has a power of 3 kW
5	Bleeder resistance power identification	This bit is expressed in hexadecimal. The bleed resistance power = flag bit *100, unit W
6	Input power type identification	A represents a single AC input; D indicates lithium battery power supply
7	Optional function mark	If it is customized or optional, this identifier identifies the customized optional content
